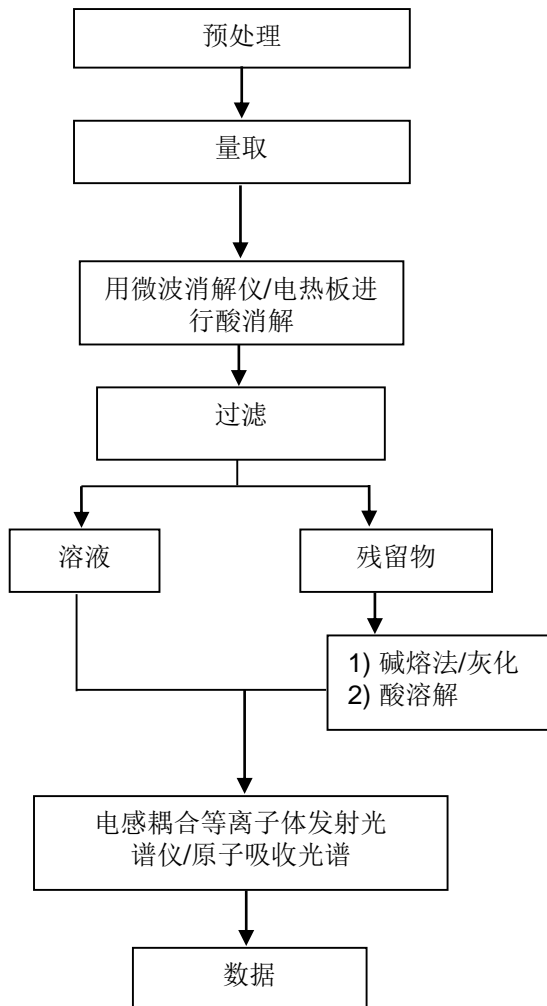

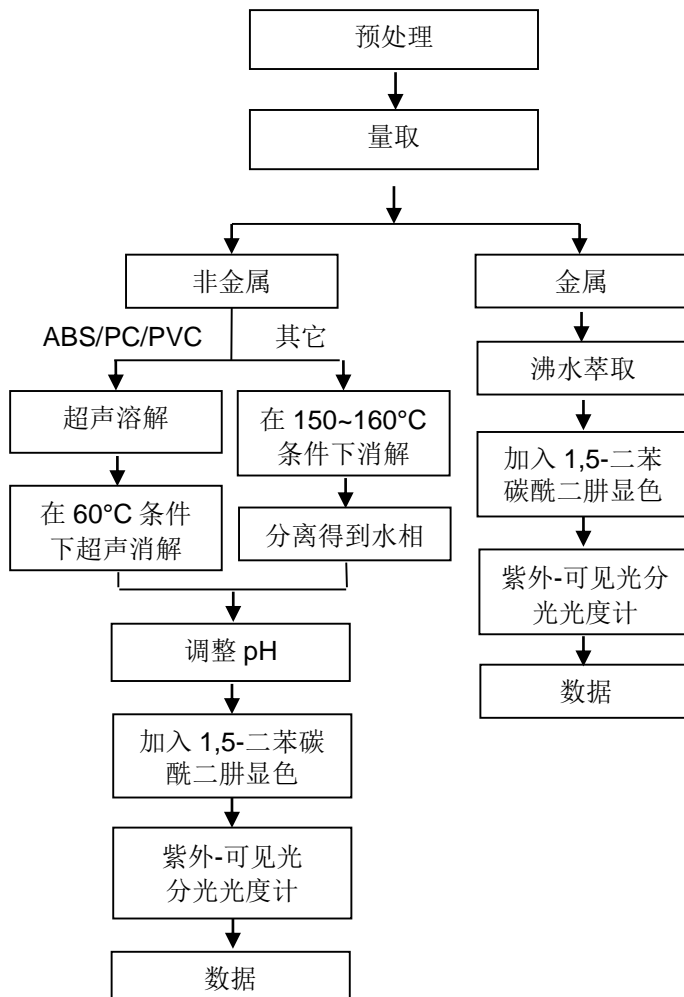

### 六价铬检测流程图



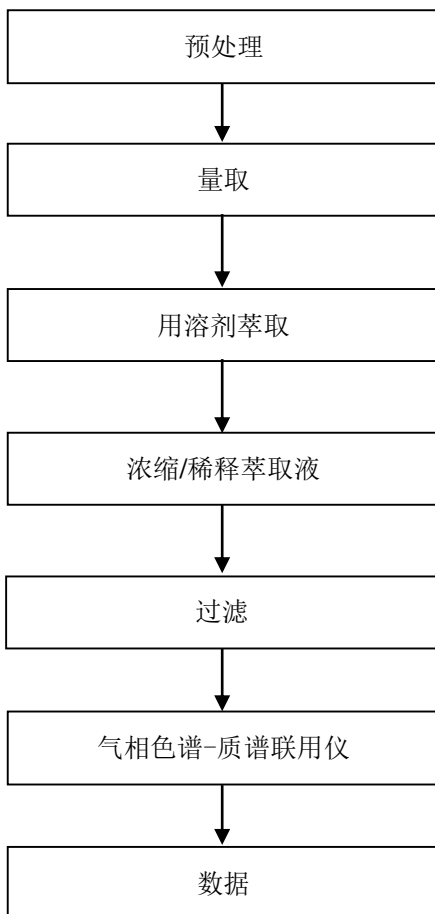

### PBB/PBDE 检测流程图



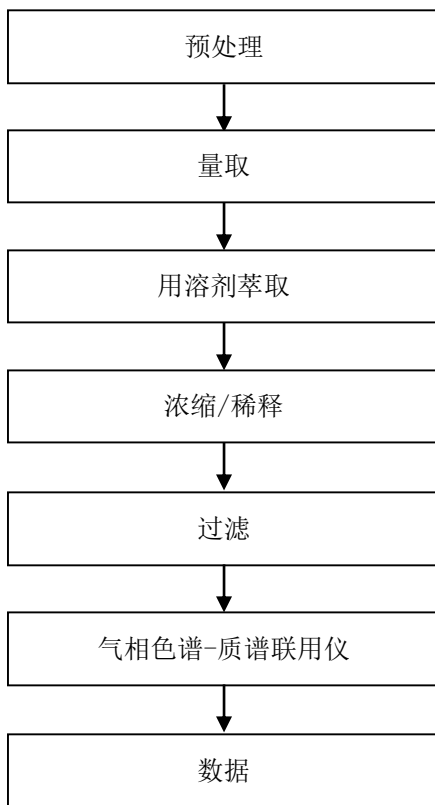

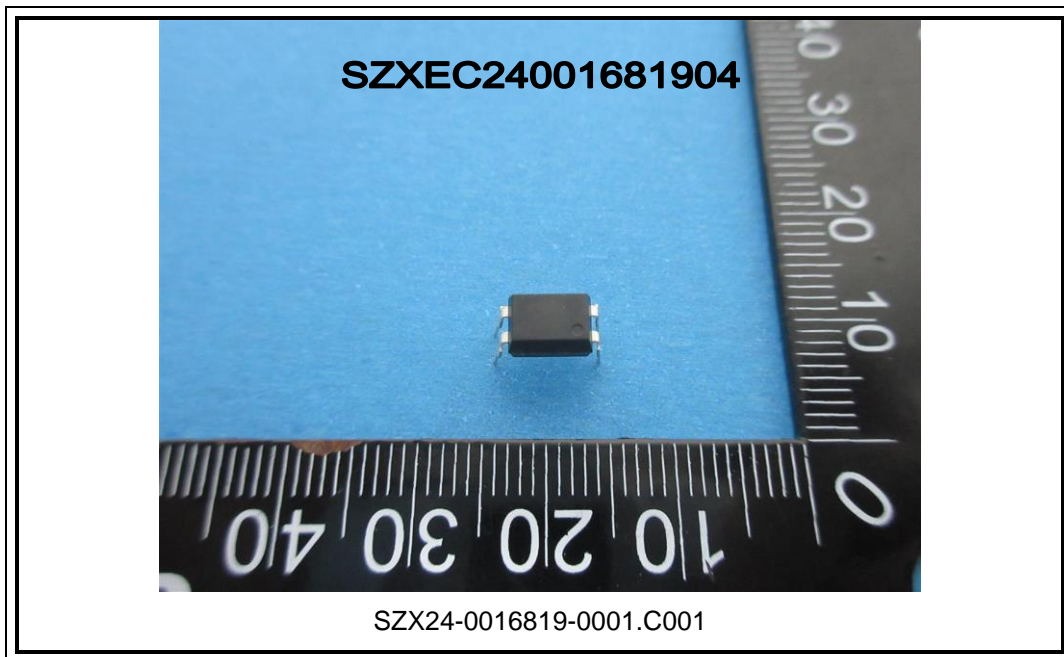
